HE Mr Ban Ki-Moon Secretary-General, United Nations First Avenue at 46th Street, New York, NY10017

By leaks to the media of the Spanish State, I learned of the report that a Group of Experts established by Security Council resolution of the United Nations. Now the report is official. With great surprise and disgust I have seen my name involved in an alleged plot to support armed groups operating in the African Great Lakes. It connects me for two reasons: first, for having assisted in the month of April 2009 in a conference held in Palma (Majorca), with the aim of fostering the Intra-Rwandese Dialog. In this respect I inform you that both the Spanish Congress of Deputies and the Senate agreed by unanimous resolutions supporting this dialogue, urging the institutions of the European Union to promote it. Just read the final manifesto of this Conference (found in the annexes to the report) for to see how far are the assistants of fomenting violence.

The second reason that I quoted in the report is because last February I traveled to Democratic Republic of Congo invited by the Government Spokesman Minister, on behalf of Prime Minister, who received us kindly. On the trip I was accompanied by the Director-General of Cooperation of the Balearic Islands, Mr Josep Ramon Balanzat, also cited in the report, including representation of the S'Olivar Foundation led by their President, Joan Carrero. I never imagined, Mr. Secretary-General, that a visit to a Member State of the United Nations was suspicious.

It hurts me deeply that the Panel has not sought my information before I got involved in veiled accusations, more typical of a pub gossip that a report which has been endorsed by the Security Council of the United Nations. The charges to S'Olivar Foundation and Inshuti Association are a set of vagueness, or directly slander that only cause the discredit of the United Nations that, instead of working for the Peace, are accomplices of the political-military apparatus members of the Rwandan Patriotic Front, some of whom are or have been members of the Rwandese Administration, accused by two judges of the French and Spanish National Court of genocide, assassination, murder of nine Spanish citizens and plundering of natural resources.

In this respect, Mr. Secretary-General, before accusing innocent citizens working to clarify the truth, do not you think that should work with the Universal Justice and attend the Rogatory of the Judge Fernando Andreu, who sent you last February, requesting the proofs contained in three reports of the UN itself, which demonstrates the truth of the accusations that have led to an Indictment of the same judge issuing the international arrest warrants for forty senior APR?

Mr. Secretary General, the Parliament of the Balearic Islands, the Government of Majorca, the Palma City Council, by unanimity of all political forces have agreed resolutions supporting the S'Olivar Foundation. For its part, the Government of Majorca and the Solidarity Fund have submitted the

justifications for subsidies to S'Olivar. Not a single euro is not justified. On the other side is a Rwandan government, in which some members are accused of the most heinous crimes against humanity, genocide of more than eight million people, Hutus and Tutsis ... And what do the UN?: Research two small NGOs that have promoted the lawsuit against the RPF.

Mr. Secretary General, at stake here is not the honesty of two small foundations, at stake is the credibility of the United Nations and your personal honesty.
